
THE ORIGINAL CORNER WAS SET BY ALFRED MILLARD IN 1857 WITH THE ORIGINAL BEARING TREES OF:

1981-KELLY FOUND A 4X4 WOOD POST & A 1" IRON PIPE, HE REPLACED THE PIPE WITH A 2" PIPE WITH BRASS CAP AND ADDITIONAL BEARING TREES OF S26E 23.15, S24W 18.70, S85W 17.30

2016-I FOUND THE 2" PIPE WITH THE BRASS CAP AND SET TIES AS SHOWN
