

09/21/1979 William F. Kelly, Forest County Certified Survey Map Vol. 3, Pg. 2 shows a found iron pipe in place for the Meander Corner.

05/21/1985 Norman A. Harrison, Forest County Survey File # 341328-19850424 shows the east line of Section 28 as a straight line between the northeast and southeast corners of Section 28 and does not show any Meander Corners.

01/25/2010 Robert O. Kamps, Forest County Certified Survey Map Vol. 8, Pg. 122 shows the east line of Section 28 as a straight line between the northeast and southeast corners of Section 28 and does not show any Meander Corners.

03/02/2000 Kim H. Pritzlaff, Forest Co Surveyor File # 341327-20000302 shows an existing 1" dia. iron pipe for the Meander Corner.

10/09/2025 I search for and could not find the iron pipe indicated as the meander corner on Kelly or Pritzlaff's surveys. I positioned the corner by projecting a line north from the Southeast corner of Section 28 through Kelly's iron pipe 259.77 feet north of the Section Corner and then extended it north a record distance of 505.99 feet north from the Section Corner as shown on the Pritzlaff survey. I set a Forest County aluminum monument with a 3" dia. cap stamped to identify the corner 2" above the swamp and made four new bearing trees to witness the monument as shown below. Note: This corner falls online between a straight line between the northeast and southeast corners of Section 28.
