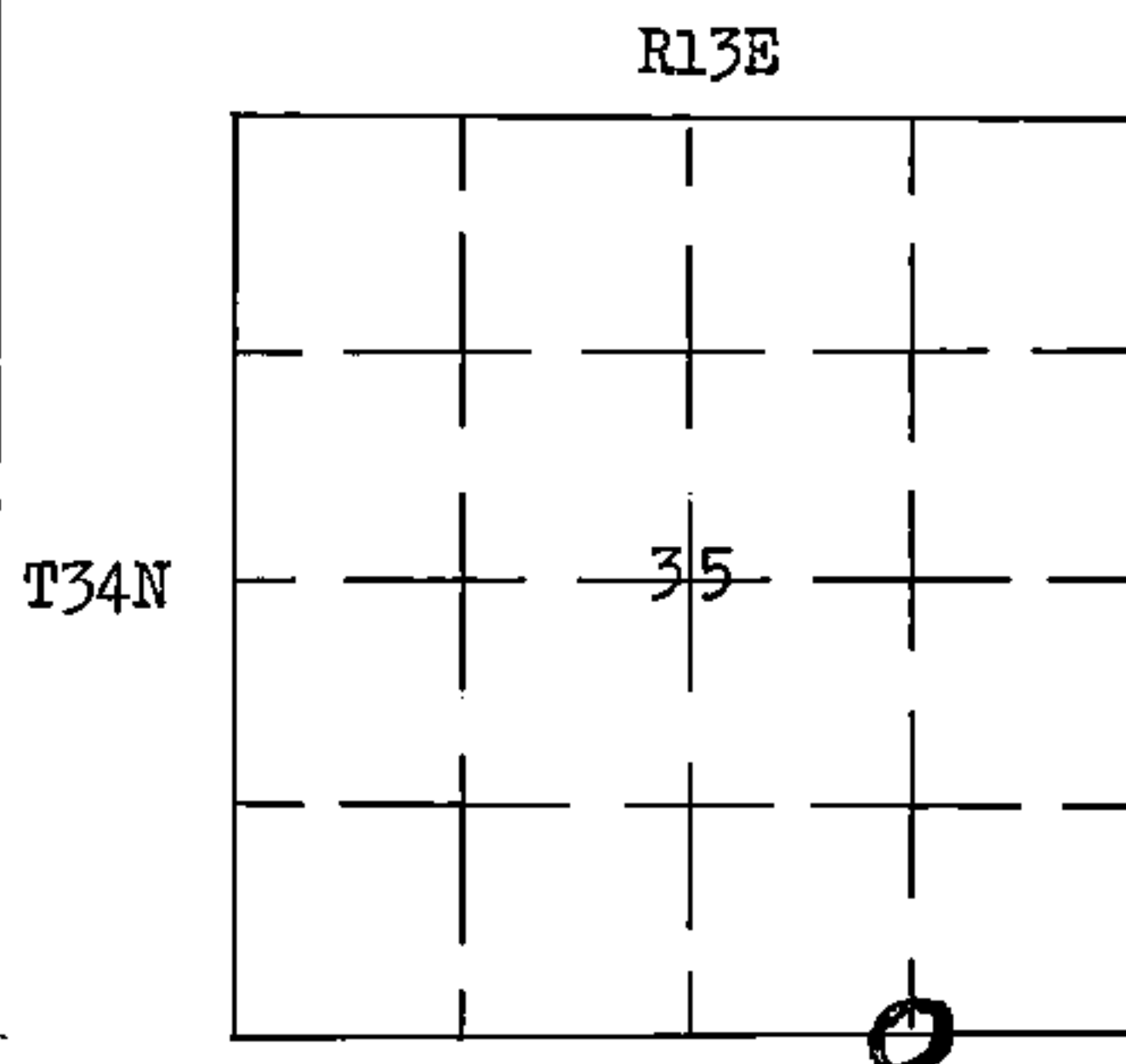

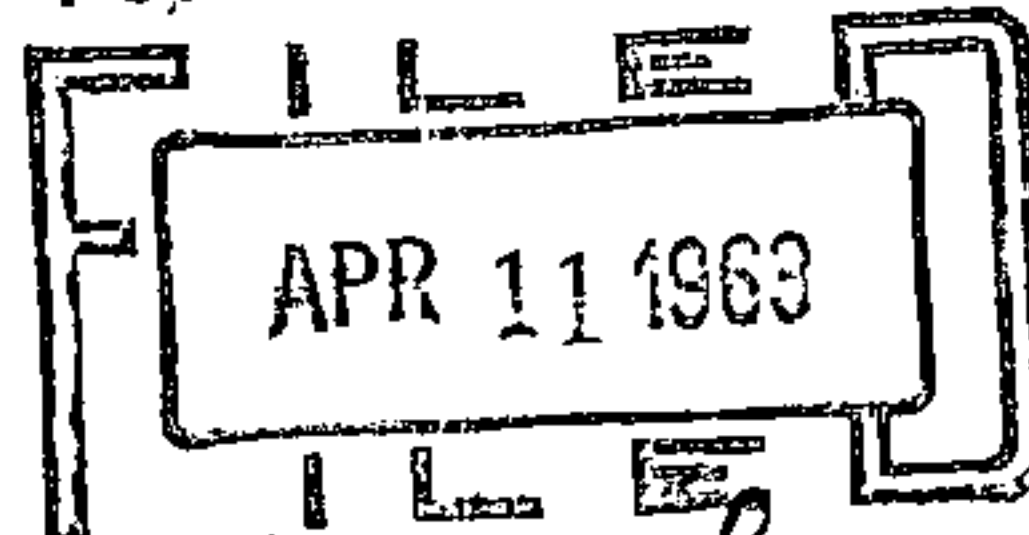

History:

There is no record of this corner having ever been previously established.

Description of monument and accessories I established to perpetuate the location of this corner:

At the point determined for the location of the corner I emplaced a:

"GALVANIZED IRON PIPE, THREE FEET LONG, ONE INCH IN DIAMETER, WITH AN ALUMINUM CAP DENOTED AS, 'KIMBERLY-CLARK CORP T33-34N E 1/16 BTWN 2 & 35 R13E SPERHAKE RLS 463 12-11-62".

Description as to how corner was located:

Since both the quarter section corner one quarter mile west, and the section corner one quarter mile east have been previously established, with a distance between them of 40.03 chains, the 1/16th corner was set 20.01½ chains from either corner, on a straight line between them.
