

In 1859, James McBride set post and made the following BTs: Sugar, 10", S.64°E., 17 links; Hemlock, 8", N.12°E., 25 links.


In 1924, N. Smith found corner and made new BTs: Hemlock, 26", S.65°W., 47 links; Hemlock, 14", N. $40\frac{1}{2}$ °E., 40 links.

In 1936, A. Vronch found scribed Hemlock post and put location poster on 6" Maple, N.63°E., 15 links.

In 1986, Alan Harrison retraced Smith's survey through center of Section 10 and set position from which the following were located: Hemlock stump, 18", N.40°E., 26.8 feet and location poster lying on ground at N.20°E., 10.9 feet.
