

In 1839, Tom Sprague set wood post with the following BTs: Hemlock, 9", S.25°W., 15 links; Sugar, 20", N.63°E., 24 links.


November 8, 1922, Nathan Smith subdivided Section 12, T.34N., R.15E. and called original corner.

October 17, 1934, Stabo and Savee found a stake 3" below road surface; also, Hemlock stump, 10", S.50°W., 33'. Metal location poster on 9" fence post east of corner ½ chain.

June 25, 1984, Alan Harrison searched area, found no evidence of original corner. Set corner by retracement of N. Smith's 1922 survey of Section 12 from With through CE 1/16 to E i.




