

Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James McBride set wood post with the following BTs: Sugar, 10", N.36°W., 13 links; Sugar, 8", N.12°E., 15 links; Sugar, 12", S.14°E., 43 links; Sugar, 8", S.64°W., 35 links.

In 1974, Tom Tallier found old, squared wood post and possible stump holes of original BTs.

July 24, 1984, Alan Harrison set proportionate position. Found squared wood post, as per Tallier. Center of stump hole, N.36°W., 8.58'; center of stump hole, N.12°E., 9.90'; center of stump hole, S.14°E., 28.40'; center of stump hole, S.64°W., 23.10'


