Original subdivision by James L. Nowlin, June 26 - July 7, 1865. Wood post set by Nowlin, with the following bearing trees:

Aspen 5"N31°E, 20 1ks. Aspen 4"N52°W, 30 1ks.

Description of corner evidence found:

Testimony from William L. Sherman who owned the E 1/2 of the SE 1/4, Section 23, T35N, R12E, from 1936 to 1972 or '73. Mr. Sherman's father owned the property from 1912 to 1936. Mr. Sherman was told by an old time surveyor named Woodberry that the corner was on the North-South fence line in the centerline of Sherman Lane. Two fence lines were found going north from Sherman Lane, one new fence and one old broken down fence east of the new fence and in line with the fence to the south. Charles Mihalko, present owner of the property to the north and east, said he put up the newer fence and the true line was the older fence to the east.

Description of monument and accessories I established to perpetuate the original location of this corner.

Set new Forest County aluminum monument in centerline of Sherman Lane on National fence line.
