

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed. In 1859, James McBride set wood post with the following BTs: Hemlock, 20", S.50°E., 10 links; Hemlock, 20", N.27°E., 23 links.


June 6, 1934, R. Cleveland--wood stake in good condition, BTs: Hemlock, 14", N.35°W., 20 links and Hemlock stump, 14", S.35°W., with no distance. New BT--Hemlock, 10", S.35°E., with tag on it.

December 30, 1936, A. Vroch--corner as in 34, southwest BT 20 links. Original BT rotted, S.50°E., 10 links.

August 15, 1985, Alan Harrison found 12" iron pipe 3 feet long in rock pile. Top of 4" x 4" wood post 2 feet long with scribe marks lying alongside of pipe. Hemlock BT stump remains at S.50°E., 6.60 feet; Hemlock (large) lying on ground, N.27°E., 15.18 feet; Hemlock (live) with BT and DBH blaze, N.35°W., 25 feet; Hemlock stump, S.35°W., 13.20 feet.
