



In 1859 James McBride established this corner and set a wood post and BTs: 7" Fir, N20°E, 8 Links 8" Hemlock, S32°W, 28 Links

5/2, 5/8 and 5/15/89 - Searched area with intensity and plantation posts east and west of area 100 to 200' found. These could have been on or close to the section line.

We restored this corner from evidence of corners easterly.
