Description of original monument and accessories and subsequent restorations: Surveyed in 1859 by James McBride. 40.00 chains West between Sections 2 and 35 set wood post. Sugar 12 in. N10E, 37 lks. Sugar 12 in. S10E, 40 lks.
A stream, 8 lks. wide, running NE bears west 18.55 chains. A stream 6 lks. wide, running south, bears east 3.10 chains. Enter Alder bottom, 2.50 chains East, bears North and South Leave Alder bottom 6.50 chains east of post.
Description of corner evidence found: A squared post 1.47 chains West of Alder Bottom from post West to stream measures 18.5 chains. From post East to stream measures 3.23 chains. From post east 6.67 chains leave Alder bottom. By evidence of natural calls to post found is accepted as being the true postion of the corner. The post has been in place for 40 years plus. Signs of older post were found along side said post.
Description of monument and accessories I established to perpetuate the original location of this corner: Replaced post with 2 inch inside diameter galvanized wrought iron pipe 5 feet long, filled with concrete with brass cap marked:
T35N R15E T35N R15E Maple 13 inch. diameter bears S86E, 17.19 feet or 26.04 lks. Maple 14 inch diameter bears N3W, 20.19 feet or 30.59 lks. 4 x 4 cedar post bears North 1.4 feet or 2.12 lks.





Replaced post with 2" inside dia. galvanized iron pipe with brass cap stamped to identify the corner. Corner references: Maple 13" S86°E 17.19 ft. Maple 14" N3°W 20.19 ft. 4"X4" cedar post North 1.4 ft. In 1988, John Schulke the corner as described on the Corner certificate Document #98040 done by Resvick. Found the following corner references: Sugar Maple 19" N01°W 17.56 ft. Sugar Maple 18" S88°E 20.24 ft. Rotten wood Post North 1.5 ft.
