
U. S. PUBLIC LAND SURVEY MONUMENT RECORD

- Identify the corner by reference to the U.S. public land survey system.
 - O = Corner monument restored.


(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859 James Mc Bride set a wood post and marked B.T.s as follow; Birch 12" S.39 E. 37 lks., Linn 16" N.44 W. 14 lks.

In 1986 I found corner position marked by an ancient stake hole in a ring of stones; found a 1 1/2" iron pipe lying down next to stake hole; found remains of original B.T.s as follow; Stp. Hole 2' S.39 E. 24.4', Stp. Hole 3' N.44 W. 9.0'; I set a 2"x 36" aluminum pipe with cap in stake hole; referenced as shown below.

- In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.) Describe witness monuments.
