




In 1859 James Mc Bride set a wood post and marked B.T.s as follows; Tamarack 10" N.11 E. 1001ks., Tamarack 8" N.66 W. 1271ks.

In 1986 I recovered the corner position from the remains of the original B.T. stumps both are badly rotted; this position fits very well with swamp calls north and south; set a 2"x 60" aluminum pipe at corner and referenced as shown below.
