


In 1859, James McBride set wood post and made the following BTs: Sugar, 12", N.10°W., 5 links; Sugar, 14", S.24°W., 22 links.

In 1911, J. A. Melindy found post by W. L. Harris and original northwest Maple stump. Made new BT: Maple, 14", S.33 3/4°W., 47 links.

In 1982, Milo Stefan found 1 1/2" well point in road between fence corners north and south. Melindy's evidence would fall in roadbed.
