




(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859, James McBride set post with the following BTs: Aspen, 10", N.55°W., 50 links; Aspen, 12", S.74°E., 27 links; Aspen, 10", N.28°E., 25 links; Aspen, 8", S.57°W., 24 links. October, 1915, J. J. Melindy found original Aspens, northwest and southeast—down and decayed. Old blazed line runs east. At 4 chains east is a Tamarack swamp. Set 5" x 5" Cedar post and made the following new BTs: Pine, 14", N2½°E., 61 5/8 links; Spruce, 11", S3/4°E., 36½ links; Pine, 14", N.89½°E., 43 1/8 links; Spruce, 12", N.56½°W., 14 5/8 links. In 1967, Kleppek found iron pipe by Connor Company. Old CCC tag on Cedar stake on north side of road. Blazed line south. No original evidence found. June 27, 1985, H. Neider found iron pipe taken out by road grading. Found stumps of Melindy's Pine BTs fit blazed lines which run east and south.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

  Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- 1. Balsam, 6", N.60°E., 32.44 feet
- 2. Sugar, 6", S.18°E., 51.11 feet
- 3. Sugar, 11", S.31°W., 57.44 feet
- 4. Sugar, 11", N.33°W., 30.43 feet
- 5. Steel Sign Post, Northeast, 0.69 feet
- 6. 2"x36" aluminum monument stamped to identify the corner
