This record shall show the jocation of the corner and shalf include all of the following nine elements (a through 1).




Quarter Corner common to Sections 1 and 2, T36N-R16E

- (b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.
 - 1858 Original post set by James McBride, witnessed by 36 W. Birch S55E 07 lks.; 12 Sugar N70W 30 lks. Corner was established on corrected closing line 40.00 chains North of corner to 1,2,11 and 12 and 39.84 chains South of standard corner on town line. Original notes contains no information as to feature calls or line trees.
 - 1930 Goodman Lumber Co. recovered rotted BT stumps and set a 4" oak post in a pile of stones, 10 feet east of a (north-south) road centerline. Other NBTs were noted as existing but not documented.
 - 1991 Corner search based on traverse between NW and SW corners of Section 1 by Coleman Engineering Company yielded no evidence of 1930 post or NBTs. Engelking Road (F.R. 2371) has been constructed between Sections 1 and 2; it is assumed the centerline was intended to follow the section line. A well-
 - supporting occupational evidence of the corner location. The position identified by the road centerline/fenceline intersection is approximately 39.5 feet North of the proportioned position. Despite the conflict with record measurements, I have accepted the existing evidence as locating the most probable position of the true corner, and monumented the road centerline (24' wide gravel) at the fenceline as extended.
- (c) in the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (witness monuments shall be made of concrete, natural stone, iron prother equally durable material.)
- (d) Show a plan view drawing depicting the relevent monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
 - 1. 5/8" x 24" rebar with plastic cap "CEC S-1767" set 6" below gravel surface.
 - 2. 1" x 36" Aluminum monument Witness Corner stamped 'WC'; West on line 33.00 feet.
 - 3. Sugar 9" N64°E 30.16 feet.
 - 4. Sugar 9" S65°E 36.37 feet.
 - 5. Sugar 9" S40°W 56.05 feet.
 - 6. Basswood 14" N29°W 37.70 feet.

(e) Describe any material discrepancy between the location of the corner as restored or reestablished prestablished and the location of that corner as previously restored or reestablished by distance and direction. Show the discrepancy on the plan view drawing under (d), above. Show the distances between the corner as previously restored or reestablished and (1) the corner as restored or reestablished, and (2) to at least 2 of the witness monuments shown on the drawing in (d), above.

Restored corner position is believed to be the most probable location of the true corner based on accepted evidence and past usage.

- (f) Was the corner restored through acceptance of (1) an obliterated evidence location, or, (2) a found perpetuated location 7
 - (1) Corner is believed to be obliterated, not lost, and was restored in accordance with observed evidence.
- (g 8, h) Was the corner reestablished through last corner proportionate methods? If so, show the method, including the directions and distances to other public land survey corners used as evidence or used for proportioning in determining the corner location?
