
INSTRUCTIONS

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set post with the following BTs: Sugar, 8", N.12°W., 9 links; Birch, 10", N.48°E., 50 links; Sugar, 10", S.78°E., 35 links; Linn, 10", S.33°W., 49 links.

October, 1925, Goodman Company found Elm post by J. Jenkins, set flue pipe 15" high, Sugar, 17", N.12°W., 9 links.

October 11, 1984, Alan Harrison found iron pipe, as per Goodman notes and 3" x 4" scribed Cedar post. From pipe, found the following: Stump hole, N.12°W., 5.94'; stump hole, S.78°E., 23.10', stump hole, S.33°W., 32.3'; nothing found at N.48°E., 33.0'.
