(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set a wood post for the corner and the following corner references: Ironwood 8" N17°E 28 1ks. Elm 6" S27°W 31 1ks.

In 1926, Goodman Lumber Company found no evidence.

In 1988, John Schulke found no evidence. Placed 2 1/2" dia. X 36" aluminum monument.
