


In 1858, James McBride set a wood post for the corner and the following corner references: Sugar 10" N79°E 4 1ks. Sugar 12" S67°W 39 1ks.

In 1926, Goodman Lumber Company set 1 5/8" pipe 4" high above the ground. Found a 10" Sugar tree N79°E 4 lks. Pipe is 8 ft. East of a wagon trail.

In 1988, John Schulke found no evidence. Placed 2 1/2" dia. X 36" aluminum monument. Forest Service road #2367 is West 135.1 feet from the monument.


