


In 1858, James McBride set quarter post and made the following BTs: Sugar, 14", N.5°W., 31 links; Sugar, 14", S.34°W., 13 links.

In 1911, J. Melendy set new 4" x 4" Elm post. Original Maple a decayed stump, N5 3/4°W., 31 links. Original Maple, 18", (green), S40 1/2°W., 13 links. Made new references: "X" on stone, 4' x 7', S.58°W., 27 links; Maple, 14", N.43°E., 65 1/4 links.

In 1987, Alan Harrison, from air photo, located search area north and west of roads. Found Melendy's rock with "X" 4' x 7', pulled for post and found live 4" Sugar growing in place. Original Sugar stump, S.40°W., 8.6 feet. Other BTs fall in road clearing.
