
INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

(a) Identify the corner by reference to the U.S. public land survey system.

O = Corner monument restored.

Section corner to Sections 4, 5, 32, and 33, T.35-36N., R.16E., Fourth Principal Meridian, Forest County, Wisconsin.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1857, Artemas Curtis set post at 80.00 chains with the following BTs: Yellow Birch, 7", N.37°E., 26 links, 17.16 feet; Yellow Birch, 16", S.48°E., 29 links, 19.14 feet; Yellow Birch, 16", S.60°W., 18 links, 11.88 feet; Tamarack, 15", N.69°W., 44 links, 29.04 feet.

June 24, 1981, Milo Stefan found a fallen 4" x 4" x 30" Cedar post with location poster attached—from which he found the following: Stump hole, N.37°E., 17.2 feet; Yellow Birch stump remains, N.48°E., 19.1 feet; Yellow Birch stump, 18"-20" D.B.H., S.60°W., 11.9 feet; Tamarack stump, 14"-16" D.B.H., N.69°W., 29.0 feet. He replaced the wooden post with a 2" x 30" aluminum monument.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

  Describe witness monuments.
