

White Birch, 10", S 05°W, 20 1ks, White Birch, 10", S 55°E, 23 1ks.

In 1970, Jean Resvick, a Land Surveyor with the U.S. Forest Service, restored the corner position by proportionate measurement between the township corner and the SW corner of Section 7. He set a 2" diameter galvanized iron pipe with a brass cap stamped as follows: T37N, R12E, R13E, S1, S6, S12, S7, 1970, S-802, from which the following bear:

Map1e	5''	S 08°E	11.7	feet
Maple	5"	s 57°W	23.8	feet
Manle	411	N 20°W	8.9	feet


A survey by Jean Resvick dated 1965 - 1971 which included Sections 4,5,6,7 is on file with the U.S.F.S.
