



Cedar On May 30, 1986, I talked to Mr. Walter Raasch of Newald, WI and he stated that in 1951 or 1952 he set the angle iron ro replace a square Cedar post that was rotting away.

Replaced angle iron with 2" diameter aluminum pipe 3 feet long with 3" diameter aluminum tablet stampled to identify corner.
