
PUBLIC LAND SURVEY MONUMENT RECORD U. S.

INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through 1).

(a) Identify the corner by reference to the U.S. public fand survey system. O . Corner monument restored.

West One Sixteenth Corner Common to Sections 4 and 33, Township 37 and 38 North, Range 16 East, Forest County, State of Wisconsin.

In 1982, Kim Pritzlaff established the corner and a 2" dia. driveable aluminum Berntsen monument stamped to identify the corner. The following corner references:

4" bears S30°E. 13.25 ft. 5" bears S64°W, Spruce 3.20 ft. Steel sign post S40°E, 1.30 ft.

In 1990, John Schulke recovered monument in place and the following corner references: Spruce 5" bears S31°E, 13.25 ft. Steel sign post SE 1.3 ft. The following new corner reference: 6" bears S49°W,
