Resvick, do hereby certify that on the 22 day of April, 1964, I found evidence of the Northeast Section corner of Section 10 Township 39 North, Range 12 East, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner:

Description of original monument and accessories and subsequent restorations:

Surveyed in 1859 by William E. Daugherty

Dependent resurvey in 1941 by H. D. Craig

Set concrete monument 24 ins. long, 6 ins. diam., 18 ins. in the ground for corner of sections 2, 3, 10 and 11 with iron post, 23 ins. long, 1 in. diam. embedded in center with brass cap mkd. T39N R12E, S3, S2, S10, S11, 1941, from which

A maple, 10 in. diam., bears N 77°E, 161 lks. dist.

A maple, 12 in. diam., bears S 18°E, 252 lks. dist.

A maple, 10 in. diam., bears S18° 30' W, 180 lks. dist.

A white pine, 16 in. diam., N 58°W, 182 lks. dist.

Description of corner evidence found:

A maple, 20 ins. diam., bears S 18° 30' W, 180 lks. dist.

A white pine stump, bears N 58° W, 182 lks. dist. scribing readable.

A maple, fallen, bears N 77°E, 161 lks. dist. scribing readable.

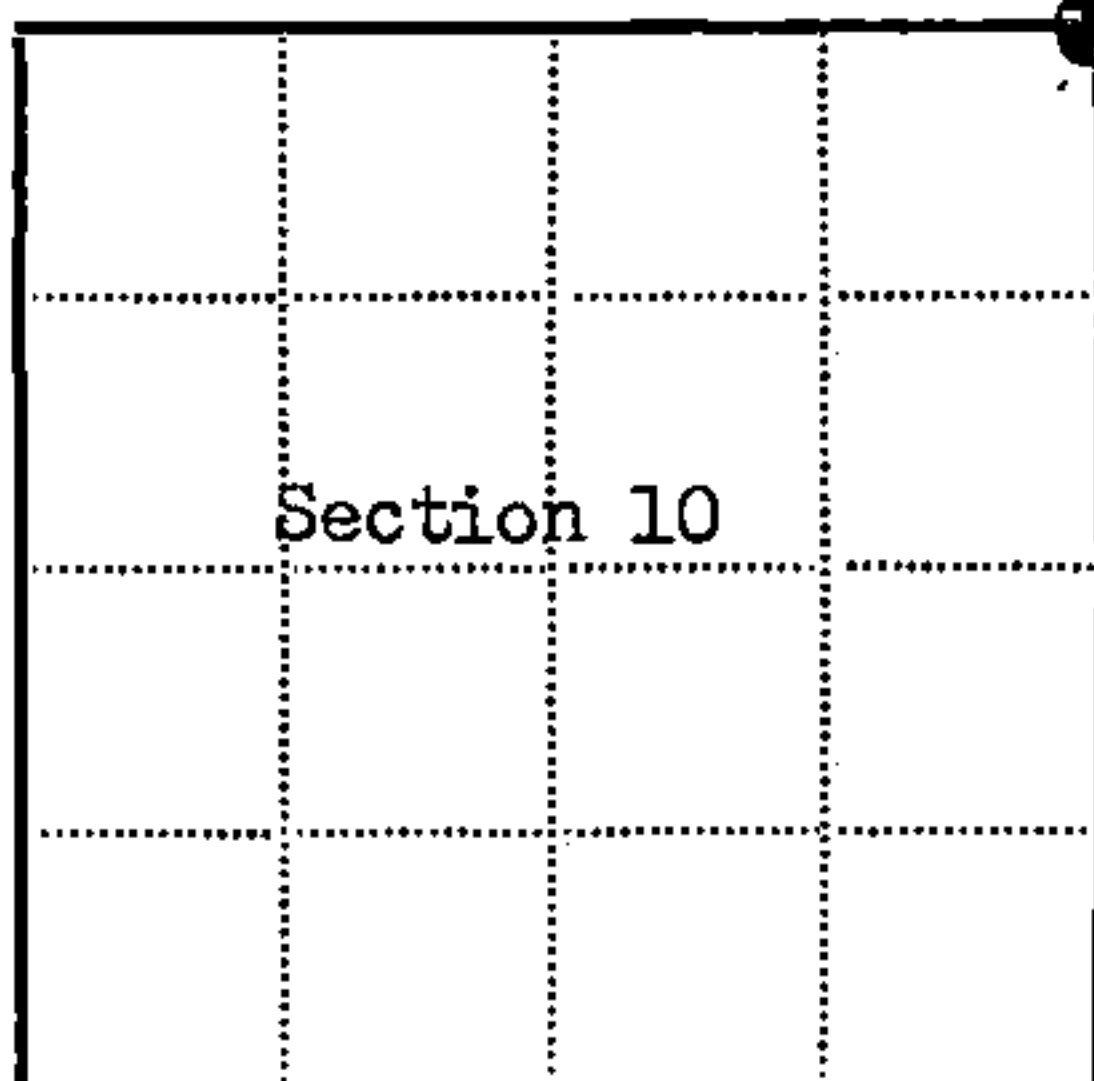
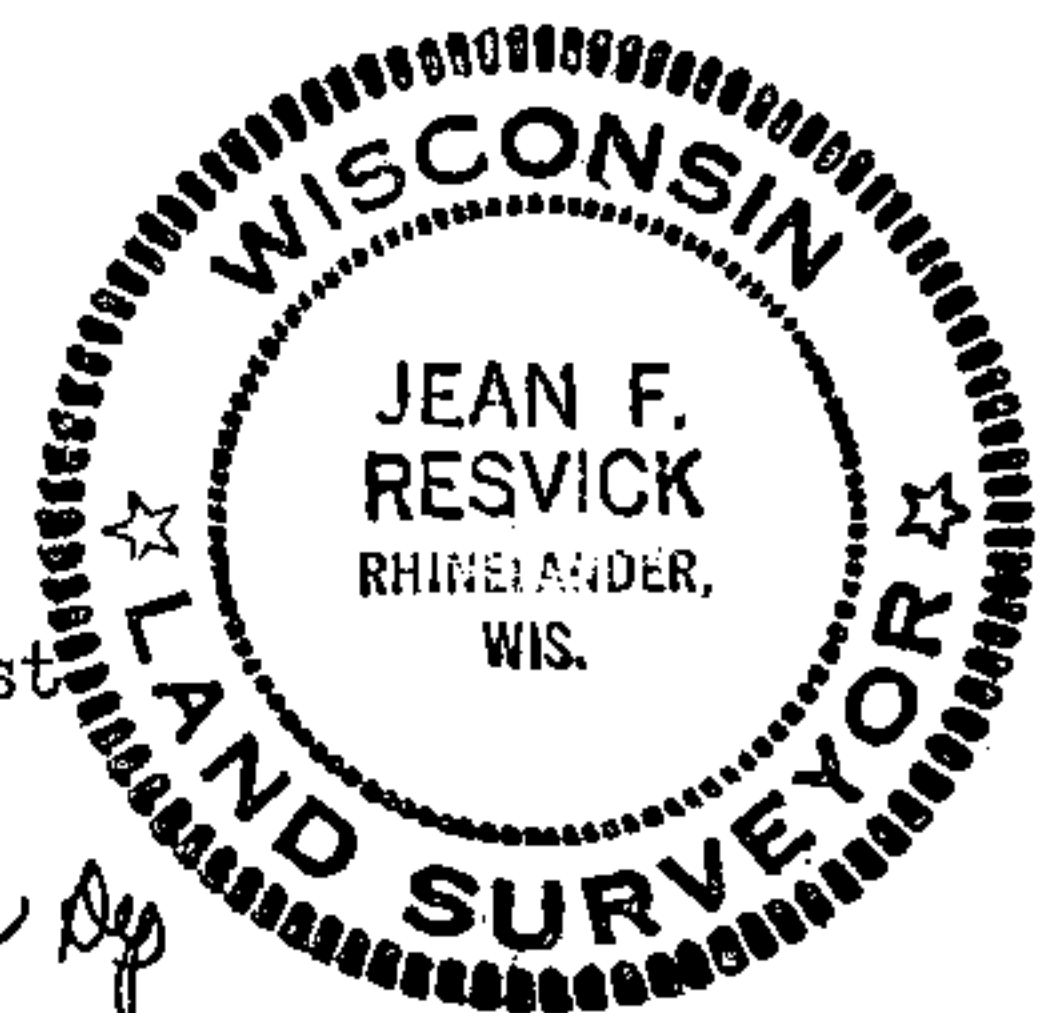
