

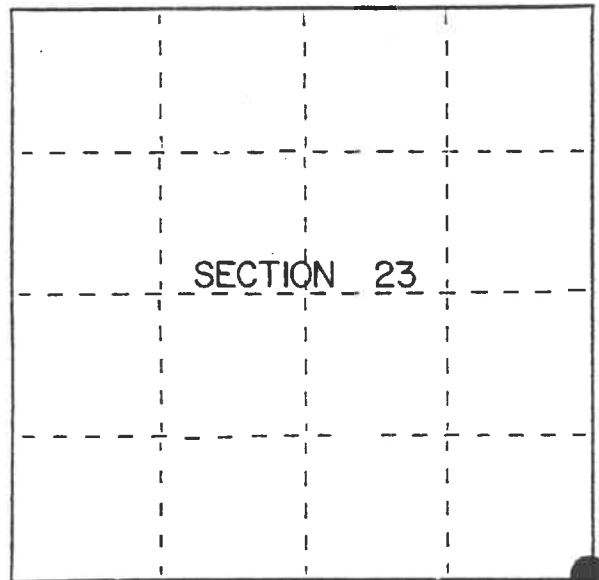

evidence of the Southeast Section
corner of Section 23
Township 41, North, Range
14 East, Fourth Principal Meridian,
as described hereon; and that from this evidence
I established a new monument and accessories
as described hereon to perpetuate the original
location of this corner.

History of original corner establishment:

Original Government Survey in 1865 by William E. Daugherty. North bet. Sections
25 and 26 at 80.00 chs. set Section Corner Post to Sections 23, 24, 25 and 26,
from which the following bear;

Birch	12"	N67°W	45 lks.
Fir	8"	S80°E	18 lks.

Description of corner evidence found:

No original corner evidence was recovered.

I restored the corner position using proportionate distance and on line between
the Meander Corner between Sections 23 and 26 located on the East Bank of the Brule
River and the Southeast Section Corner of Section 24.

Description of monument and accessories I established to perpetuate the original location of this corner.

At the corner position, set a 2 1/2 inch diameter aluminum pipe monument, 3 feet long,
3 inches above the ground, with an aluminum cap stamped; T41N R14E, S23, S24, S25,
S26, 1991, S-1634. From which the following new blazed and scribed bearing trees bear;
(measurements are taken to a nail in side of tree)

S. Maple	7"	N75°E	34.87 feet
S. Maple	5"	S33°E	37.17 feet
R. Maple	8"	S17°W	15.43 feet
Hemlock	11"	N44°W	34.06 feet
Steel Sign Post		S65°W	0.70 feet

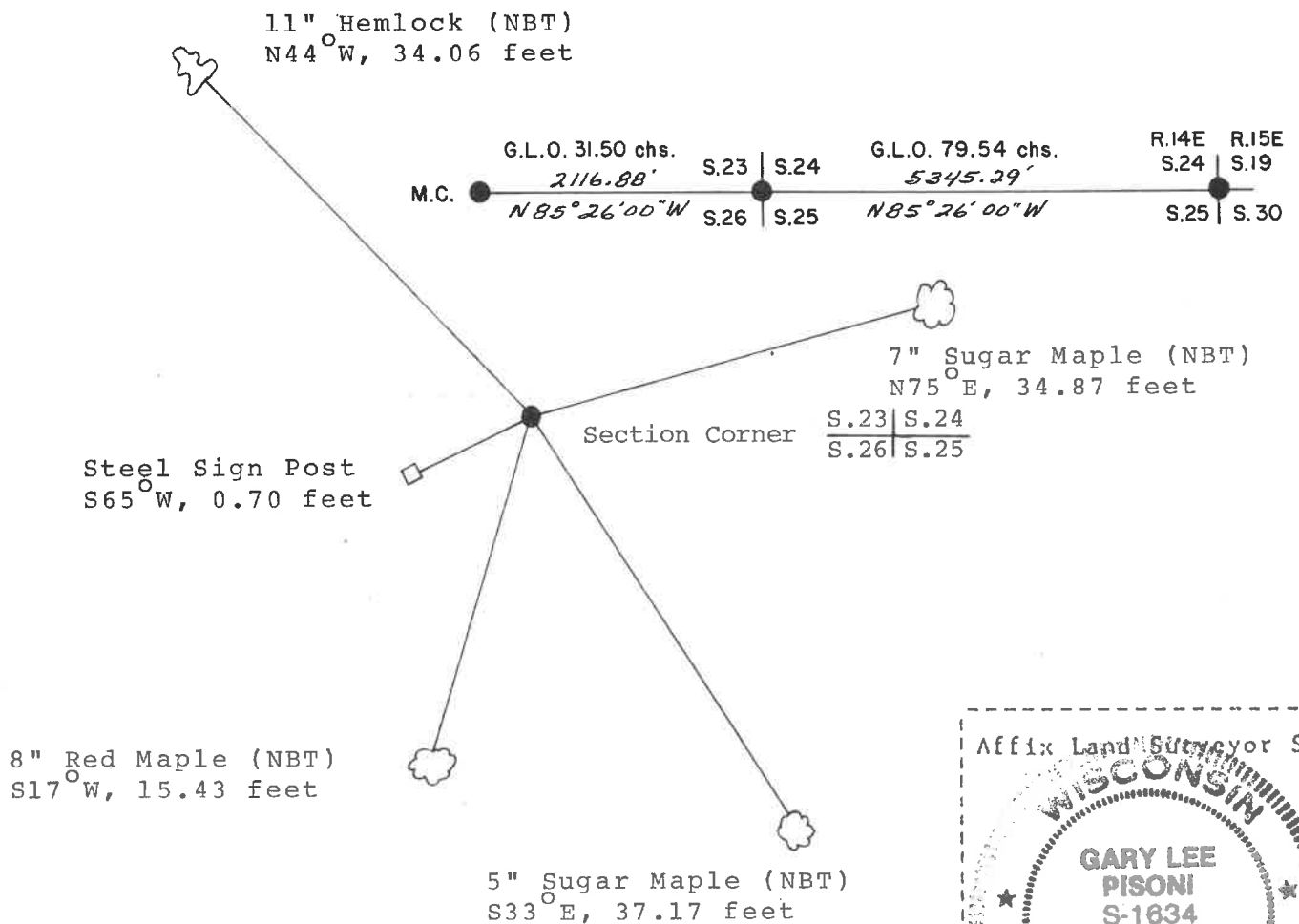
