

HISTORY OF ORIGINAL CORNER ESTABLISHMENT AND SUBSECUENT RESTORATION AND DESCRIPTION OF ANY RECORD, MONUMENT OCCUPATIONAL, TESTIMONIAL OR OTHER EVIDENCE CONSIDERED:

THE ORIGINAL QUARTER CORNER WAS ESTABLISHED IN 1865 BY JAMES NOWLIN. ORIGINAL BEARING TREES: BIRCH 14" SSE 40LKS., BIRCH 10" N59E 50LKS. 12/28/99 CHARLEY BRINKMEIER AND GERRY BAHAR SEARCHED ALONG A BLAZE LINE FROM AN OWENS-ILLINOIS 1960'S SURVEY, WITH NO RECORD OF ANYTHING BEING SET AT THE SOUTH 1/4. (MAP # 10382 IN LANGLADE CO. SURVEYOR'S OFFICE) FOUND NOTHING. WE SET A 2" X 30" BRASS CAPPED LANGLADE CO. MONUMENT ON THE BLAZE LINE AT A PRORATED DISTANCE ACCORDING TO THE ORIGINAL GOV'T NOTES.


