

CERTIFIED LAND CORNER RESTORATION

I, Jean F. Resvick, do hereby certify that on the 8th day of October, 1975, I found evidence of the Southeast corner of Section 13 Township 33 North, Range 14 East, Fourth Principal Meridian, as described hereon; and that from this evidence I established a new monument and accessories as described hereon to perpetuate the original location of this corner:

Description of original monument and accessories and subsequent restorations:

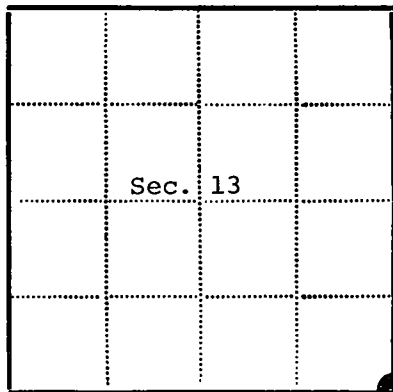
- Surveyed in 1857 by Artemas Curtis
- 80.00 chains North between Sections 19 and 24 set wood post
- S. Maple 12", S32W, 28 Lks.
- Hemlock 12", N28W, 56 Lks.
- Hemlock 18", N66E, 28 Lks.
- Hemlock 10", S72E, 7 Lks.
- 8.00 chains South swamp bears East
- 13.90 chains South stream 8 Lks. runs S.E.
- 11.50 chains North enter swamp bear N.E.
- 12.29 10" Black Ash

Description of corner evidence found:

- Found post point
- fallen Hemlock S72E, 7 Lks., scribed
- Swamp edge North 11.50 chains
- 13.90 chains South stream 8 Lks., runs S.E.
- 12.29 Black Ash stump North of corner.

Description of monument and accessories I established to perpetuate the location of this corner:

- Replaced post point with 2 inch inside diameter galvanized iron pipe 3 feet long filled with concrete with brass cap stamped: T33N, R14E, R15E, S13, S18, S24, S19, 1975, S-802, from which the following bear:
- Maple 8", N77E, 29.29 ft.
- Maple 8", S44E, 37.85 ft.
- Maple 7", S61W, 13.36 ft.
- Maple 10", N57W, 38.91 ft.
- Chiseled 3 inch square on SE corner of large rock outcrop which bears N16W, 121.55 ft. paint square red. Roch outcrop 11 ft. by 28 ft. by 8 ft. high.
- Set steel sign post 1 ft. SW of monument.
