AT THE REQUEST OF E.F. CONNORS AND D.J. STENSLAND, OWNERS OF SAID LANDS. THAT SAID SURVEY HAS BEEN MADE TO ESTABLISH THE BOUNDARY LINES OF THE E.F. CONNORS LOT AND THE D.J. STENSLAND LOT.

DESCRIPTION OF E.F. CONNORS LOT: COMMENCING AT THE 1/4 CORNER OF SECTION 4+3, T.34N.-R.10E; THENCE S0°55'E 561.34 FEET TO THE MEANDER CORNER ON ENTERPRISE LAKE; THENCE S81°09'56"E 55.80 FEET TO AN IRON PIPE WHICH IS THE POINT OF REAL BEGINNING; THENCE N0°48'31"W 195.55 FEET TO A CAR AXLE; THEN N58°47'30"E 110.70 FEET TO AN IRON PIPE; THENCE S3°10'21"E 275.55 FEET TO AN IRON PIPE; THENCE N78°16'35"W 109.45 FEET TO THE POINT OF REAL BEGINNING.

THAT SAID PARCEL CONTAINS ALL LANDS LYING BETWEEN THE EAST AND WEST BOUNDARIES EXTENDED TO THE SHORELINE OF ENTERPRISE LAKE.

THAT SAID LOT CONTAINS 25,908 SQUARE FEET OR 0.59 ACRES MORE OR LESS.

STENSLAND LOT: COMMENCING AT THE 1/4 CORNER SECTION 4+3, T.34N.-R.10E.; THENCE S0°55'E 561.34 FEET TO THE MEANDER CORNER ON ENTERPRISE LAKE; THENCE S81°09'56"E 55.80 FEET; THENCE S78°16'35"E 109.45 FEET; THENCE N83°04'55"E 99.96 FEET TO AN IRON PIPE WHICH IS THE POINT OF REAL BEGINNING; THENCE N14°13'25"W 301.95 FEET TO AN IRON PIPE; THENCE N53°41'50"E 60.25 FEET TO AN IRON PIPE; THENCE S22°09'48"E 311.63 FEET TO AN IRON PIPE; THENCE S66°36'41"W 100.16 FEET TO THE POINT OF REAL BEGINNING.

THAT SAID PARCEL CONTAINS ALL LANDS LYING BETWEEN THE EAST AND WEST BOUNDARIES EXTENDED TO THE SHORELINE OF ENTERPRISE LAKE.
