particularly described as follows: Commencing at the East $\frac{1}{4}$ corner Section 3, thence
 $55^{\circ}48' E$ along the East line Section 3, 69.65 feet to the center of the town road; thence along
the centerline of the town road $N 66^{\circ}21' W$ 1281.03 feet; thence $N 2^{\circ}49' W$ 274.75 feet to the
point of real beginning; thence continue $N 2^{\circ}59' W$ 425 feet more or less to the shore of
Post Lake; thence northwesterly along the shore of Post Lake to the Easterly line of the


