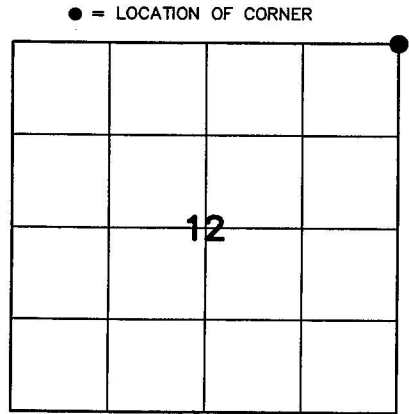

1981-KELLY FOUND A 4X4 WOOD POST & A 1" IRON PIPE, HE REPLACED THE PIPE WITH A 2" PIPE WITH BRASS CAP AND ADDITIONAL BEARING TREES OF N64E 10.25', S9E 18.70', N23W 10.70'

2016-I FOUND THE 2" PIPE WITH THE BRASS CAP AND SET TIES AS SHOWN

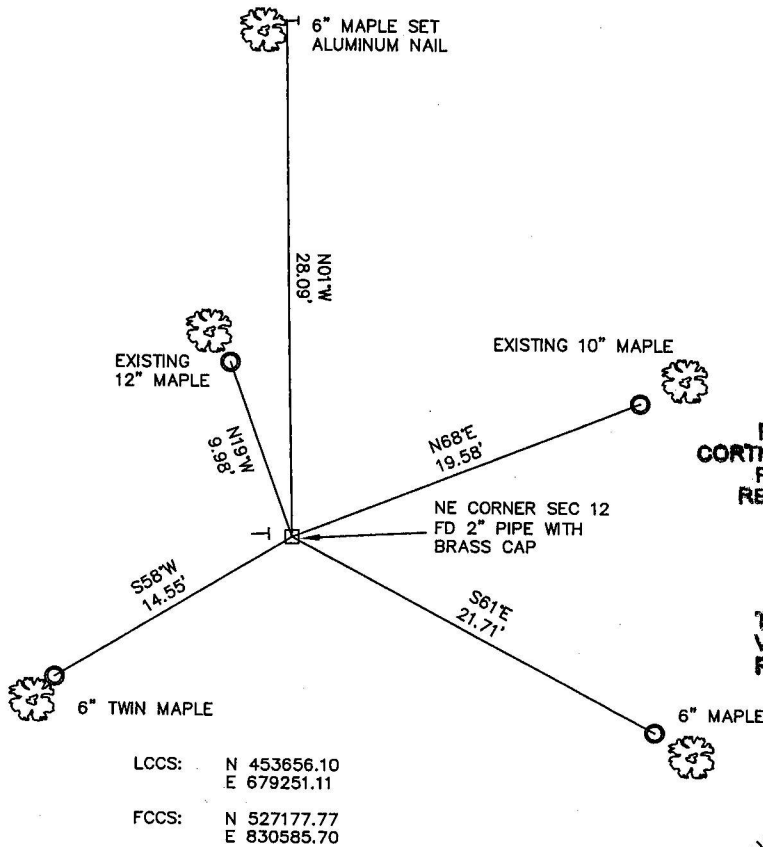

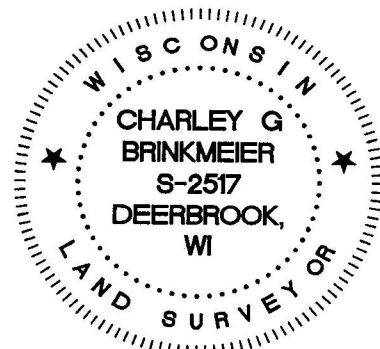
