

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859, James McBride, section corner falls in lake--set witness corners on north, south, east, and west sides of lake and made BTs.


In 1909, N. Smith found south witness post and set N 1/8 to Sections 15 and 16. Witnesses o.k.

In 1934, J. W. White found north witness post and two BTs: White Birch, 8", Northwest, 12 feet; Tamarack, 9", Southwest, 12 feet.

In 1985, Alan Harrison, lake was dammed in mid-1960s, causing bog mats to float and move from original positions. Corner restored by retracement of Smith's survey from West through North 1/16 corners of Section 15. Section corner witnessed on north and south shore of lake.
