


In 1859, James McBride set a wood post with the following BTs: Sugar, 15", N.2°W., 56 links; Sugar, 12", N.57°E., 20 links; Sugar, 10", S.47°E., 26 links; Birch, 24", S.15°W., 27 links.

In 1909, N. Smith used this corner but did not make any new BTs.

In 1985, Alan Harrison searched area, but due to roads and cultivation no evidence was found. He then used the intersection of roads east, west, and south and fence line to north. Position fits N. Smith's survey east and north. Marked position with a 2" x 36" aluminum monument with cap stamped for corner.
