


(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859 James McBride set a wood post and bearing trees; Elm, 10", N.59°W., 18 links, (11.88 feet), Elm, 10", N.48°E., 25 links (16.50 feet), Elm, 12", S.33°E., 72 links (47.52 feet), Elm, 16", S.31°W., 37 links (24.42 feet), North 9.50 chains pond and marsh bears East and West; West 16.0 chains stream runs Southwest.

In 1978 Jean Resvick, R.L.S., at position and of T road South and fence North set 2" inside diameter galvanized pipe 3 feet long, filled with concrete with brass cap stamped T.34N., R.14E., S.20, S.21, S.29, S.28, 1978, S-802; Bearing trees and ties are as follows: U.S.G.S. Bench Mark TT31L, 1939, North, 26.95 feet, Basswood, S.31°E., 97.69 feet, North corner of boiler house of the dry kiln, S.37°W., 120.0 feet, Monument 0.5 feet below surface.

On October 14 1993, Alan Harrison R.L.S., found corner monument and ties. Set a P.K. flush with black top over monument.


