
INSTRUCTIONS

In 1857, Artemas Curtis set wood post with the following BTs: Sugar, 10", N.8°W., 7 links; Ironwood, 9", S.20°W., 24 links.

May 29, 1984, Milo Stefan set proportionate position -- searched area, found no evidence of corner location.


