

In 1859, James McBride set wood post with the following BTs: Hemlock, 8", N.70°E., 14 links; Hemlock, 10", N.71°W., 51 links.

In 1907, J. J. Melindy found original BTs and set a new Hemlock stake and the following BTs: Maple, 20", N.46°W., 34.65 feet; Hemlock, 12", N.35°E., 21.12 feet.

April 17, 1977, J. Resvick found post and pipe--snow on ground, did not find bearing trees.

June 4, 1985, Alan Harrison found 2" iron pipe and wood post. Found large stump depression, N.46°W., 34.65 feet; stump hole, N.35°E., 21.1 feet; root pattern of Hemlock, N.70°E., 9.2 feet.
