


In 1859, James McBride set a wood post with the following BTs: Hemlock, 14", N.77°W., 36 links; Fir, 10", N.40°E., 38 links; Hemlock, 12", S.41°E., 19 links; Birch, 12", S.40°W., 12 links.

In 1909, J. J. Melendy found original corner and BT remains. Set a new Cedar post and made an "X" on a 3' x 4' x 12" stone, S.75°W., 24.8 feet.

In 1986, Alan Harrison (RLS) found wood post lying next to a 2" iron pipe in a mound of stone and "X" on a 3' \times 4' \times 12" rock, S.75°W., 25 feet from found pipe. Accepted pipe as true location of corner and monumented same.
