

In 1859, James McBride established this corner and set a wood post and BTs: 18" Birch, S67°E, 18 Links 8" Sugar, N79°W, 18 Links

4/21/89 - 4/22/89 - 5/8/89 searched area very thoroughly and found fallen cedar post with location poster attached with small mound of stone. This post is supported by remains of the original birch BT stump and a stump hole for the sugar.

6/6/89 I restore this corner at the old post point location.


