





In 1859, James McBride set post with the following BTs: Birch, 10", N.48°W., 7 links; Hemlock, 14", N.17°E., 30 links; Sugar, 12", S.32°E., 43 links; Sugar, 16", S.32°W., 82 links.

In 1965, Jean Resvick found a scribed post 33 feet north of centerline of road 30" above ground with a 3/4" iron pipe alongside post. Found a scribed post 33' south of centerline of road (lying down). Also found a Maple stump at S.32°W., 54.1 feet. Placed a 2" x 30" galvanized iron pipe 8" below the surface of the road to mark the corner. Replaced the north witness post with a 2" x 60" galvanized iron pipe and replaced the south witness post with a 2" x 30" galvanized iron pipe.


