


In 1858, James McBride set wood post 42.10 chains with the following BTs: Birch, 8", S.48°E., 18 links; Sugar, 14", N.12°E., 25 links.

In 1909, N. H. Smith found post and made new BT: Sugar, 6", S.29°W., 13.86'

August 30, 1984, Belliveau found old Elm post point 3" below surface, next to fence corner post—old fences run south and west. Rock pile around corner post and post point. No trace of original BTs or Smith's 6" Sugar were found.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)
