
U. S. PUBLIC LAND SURVEY MONUMENT RECORD

INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through 1).

- (a) Identify the corner by reference to the U.S. public land survey system.

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

Found monument and sign post as set by Pritzlaff and Lenca in 1985 in good condition. All three BTs down and/or dead. We made two new BTs:

White Spruce, 4", N.75°W., 61.07' Black Cherry, 3", N.7°W., 72.47'

5. White Spruce, 4", N.75°W., 61.07'.


6. Black Cherry, 3", N.7°W., 72.47'.
