
INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

(a) Identify the corner by reference to the U.S. public land survey system.

O = Corner monument restored.

Section corner to Sections 25, 26, 35, and 36, T.35N., R.16E., Forest County, Wisconsin.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whather the monument was found or placed.

In 1858, James McBride set a wood post with the following BTs: Hemlock, 10", N.69°E., 40 links; Hemlock, 12", S.78°E., 23 links; Sugar Maple, 10", S.51°W., 47 links; Hemlock, 10", N.71°W., 22 links.

In June, 1982, Milo Stefan found a post hole 16" to 18" deep. From hole, he pulled in search of original BT evidence and found the following: Hemlock stump, N.78°E., 15.2 feet; Sugar stump, S.51°W., 31.0 feet; Stump hole, N.71°W., 14.5 feet; Stump hole, S.69°E., 26.4 feet. Accepted post hole as best available evidence and placed a 2" x 36" aluminum monument in a mound of stone, stamped for corner location.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

 Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed, Indicate north,

1. 2" x 36" aluminum monument stamped to identify the corner.


