
INSTRUCTIONS

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

(a) Identify the corner by reference to the U.S. public land survey system.

O - Corner monument restored.

Quarter corner between Sections 4 and 33, T.34-35N., R.16E.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1857, Artemas Curtis set post with the following BTs: Yellow Birch, 10", N.5°W., 21 links; Fir, 9", S.37°W., 6 links.

December 20, 1934, Leonard Sobczak found Cedar post 28" high in good condition. Found no original BTs. Put tag on post. Corner is located in swamp 4 chains 56 links south of road. Poster on roadside describes location of corner.

April 16, 1984, Alan Harrison measured 4.56 chains from road south as per 874 slip. Found scribed Cedar stump. Found old post remains and post point in mud and steel sign post left by Resvick. From post point, N.5°W., 13.9', Birch stump remains; S.37°W., 4.0', root system of connifer.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

- 5. Scribed Cedar stump, 12", S.11°E., 25.0'
- 6. 2" x 60" aluminum monument stamped to identify the corner.
