History of original corner establishment:

Corner established by H. C. Lawrence, Registered Land Surveyor, in 1950. He ran a random line South 3° 00' W. from Section Corner 7, 12, 18, 13 a distance of 79.20 chains to a point 7.00 chains west of Section Corner 13, 18, 19, 24. Set the North 1/16 corner at 19.80 chains, equidistant between NW corner and 1/4 corner. Set a 6" Cedar Post from which Tamarack 8" bears N 67° W 56½1ks.

Description of corner evidence found:

Recovered H. C. Lawrence's 6" cedar post, Squared and Scribed N 1/16 S 13, N 1/16 S 18 down and laying under the snow. The OBT Tamarack 8" was also down, buried under snow. From H. C. Lawrence's calls on old random line was able to locate area and recover corner. The point of post checked with bearing and distance from stump of Tamarack BT. BT was scribed N 1/16 S 13 BT.

Description of monument and accessories I established to perpetuate the original location of this corner.

Replaced point of 6" Cedar Post with 1" OD iron pipe with 2" brass cap.

Pipe projects 12" above ground. Cap stamped.
