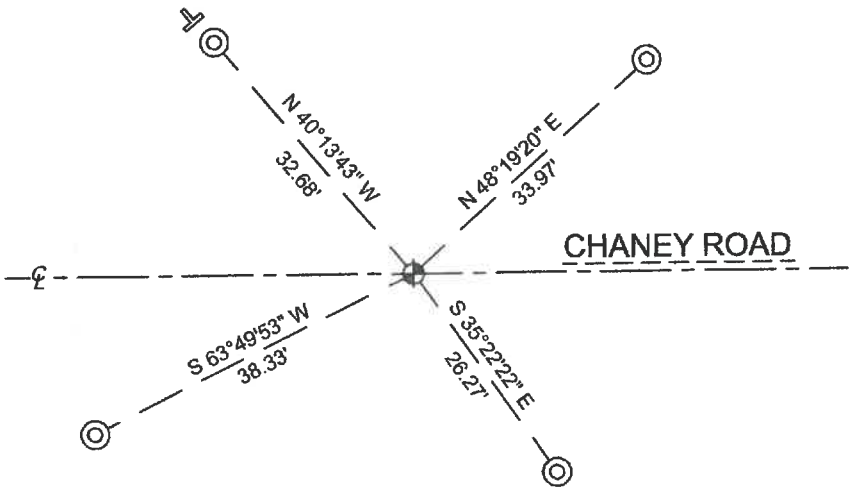

June 22, 2023 - I found a 0.5" diameter iron rod near the centerline of Chaney Road.
I established 4 new reference monuments as shown below.
