


In 1973, Thomas Arnott, RLS, set a railroad spike at the intersection of County Highway "H" and Venters Road, for the corner position. Fence line bears West. Set an iron pipe S.55°E., 41.41 feet. An Elm, 8", bears N.59°E., 44.02 feet.

In 1982, John Fisher, RLS with North Country Surveyors, found railroad spike and corner references as set by Thomas Arnott in 1973. Set a 2"x36" aluminum monument for a Witness Corner and the following new bearing trees listed below.

In 1995, Alan Harrison, RLS with the Forest Service, found the railroad spike and corner references as set by Thomas Arnott and John Fisher.
