



In 1982, Milo Stefan, RLS, found stump remains of 3 original bearing trees by survey of town line east and west and from distances of original line tree west. Set a 2" x 36" Aluminum Monument and the following bearing trees; Black Spruce, 4", N.16°E., 20.12 feet, Red Maple, 7", S.69°E., 37.25 feet, Black Spruce, 7", S.26°E., 31.89 feet, White Birch, 10", S.41°W., 9.86 feet, Steel Sign Post, west, 1.90 feet.

On 11-17-93, Alan Harrison, RLS, found the monument and bearing trees as by Milo Stefan in 1982. The Southeast Black Spruce is dead and he cut down the White Birch for G.P.S. obsetvations. Also made 2 new bearing trees; Red Maple, 7", S.02°W., 36.82 feet, Red Maple, 6", S.70°W., 29.59 feet.




