

U. S. PUBLIC LAND SURVEY MONUMENT RECORD


INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

(a) identify the corner by reference to the U.S. public land survey system.

O = Corner monument restored.

Quarter Corner to Sections 21 and 28, T.36N., R.16E.



(b) Describe any record evidence, monument evidence, occupational evidence, tostimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1858, James McBride set wood post with the following BTs: Sugar, 10", S.65°E., 32 links; Sugar, 6", N.24°W., 13 links.


In 1926, Goodman Lumber Company set a flue pipe 20" high in place of 4" Maple post set by Blackwell Company. Maple stump, 11", N.20°W., 10 links.

February, 1985, H. Neider found flue pipe and a Basswood, southeast, with old Forest Service tag.

June 10, 1985, Alan Harrison found a 2" iron pipe with post hole alongside. At S.65°E., 21.21 feet is a Sugar stump and at N.24°W., 8.58 feet is a stump depression.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

 Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- 1. 2" x 36" aluminum monument stamped to identify the corner.
- 2. Sugar, 7", N.54°E., 25.70 feet
- 3. Sugar, 6", S.87°W., 59.81 feet
- 4. Sugar, 7", N.30°W., 57.36 feet
- 5. Steel Sign Post, Southeast, 1.40 feet
