
INSTRUCTIONS:

(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.


In 1858, James McBride set wood post and made the following BTs: Sugar, 10", N.60°W., 12 links; Lind, 8", N.66°E., 19 links; Birch, 20", S.43°E., 48 links; Sugar, 10", S.40°W., 44 links.

In 1911, J. Melendy set Elm post and made new BTs: Maple, 16", N.44°W., 31.68 feet; Maple, 12", N.50°E., 30.36 feet.

In 1927, Goodman Company found hardwood post, original Birch (dead), and dried stump. Sugar is still alive. Set 2" flue pipe.

In 1987, Alan Harrison found flue pipe lying on ground, post hole with wood remains, Sugar stump, N.50°E., 30.4 feet, root holes, N.44°W., 31.7 feet, Sugar regrowth, S.40°W., 26.3 feet.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.) Describe witness monuments.
- Show a plan view drawing (d) depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- A 2½" x 36" aluminum monument stamped to identify the corner, in a mound of stone.
- Sugar, 7", N.15°E., 32.07 feet.
- Sugar, 7", S.23°E., 37.53 feet.
- Sugar, 7", S.40°W., 27.22 feet.
- Sugar, 7", N.77°W., 20.71 feet.
- Steel Sign Post, 6', Southeast, 1.07 feet.
