

In 1858, James McBride set wood post with the following BTs: Cedar, 10", N. N. 16 links; Fir, 8", N.50°E., 7 links.

In 1926, Goodman Company set 4" Cedar post and 1 5/8" pipe 16" high. Dead Cedar (leaning), blazed but no scribe marks visible. Small Balsam, squared, nearby.

In 1987, Alan Harrison found cut line in swamp. A squared Balsam post and a location tag, WNW, 22 feet from post on 20" Cedar. From post at N.43°W., 10.6 feet, is a large Cedar fallen over. Did not find Goodman's pipe.
