

U. S. PUBLIC LAND SURVEY MONUMENT RECORD


INSTRUCTIONS:

This record shall show the location of the corner and shall include all of the following nine elements (a through i).

(a) Identify the corner by reference to the U.S. public land survey system.

O - Corner monument restored.

Quarter Corner to Sections 11 and 12, T.37N., R.13E.



(b) Describe any record evidence, monument evidence, occupational evidence, testimonial evidence or any other material evidence you considered, and whether the monument was found or placed.

In 1859, William Daugherty set wood post with the following BTs: Cedar, 12", N.65°E., 12 links; Hemlock, 12", S.39°W., 15 links.


In 1937, Lorenz found new Cedar post. Put location poster on 4" Cedar. Corner bears N.80°E., 24 links.

In 1984, H. Neider found Cedar tipped out with location poster. No evidence of post. Possible post hole.

June 19, 1985, Alan Harrison found position as per Neider. Area is in Aspen regeneration. No evidence of original BTs. Accepted post hole as best available evidence of corner position. It appears this fits farm corners in Section 21 by photo interpretation.

- (c) In the plan view drawing below, provide reference ties to at least 4 witness monuments, or, if the location is within a municipality, to at least 2 witness monuments. (Witness monuments shall be made of concrete, natural stone, iron or other equally durable material.)

 Describe witness monuments.
- (d) Show a plan view drawing depicting the relevant monuments and reference ties which is sufficient in detail to enable accurate relocation of the corner monument if the corner monument is disturbed. Indicate north.
- 1. 2" x 36" aluminum monument, in a mound of stone, stamped to identify the corner.
- 2. Red Maple, 6", S.55°W., 63.12 feet
- 3. Cedar stub, 10", S.80°W., 15.14 feet
- 4. Red Maple, 7", West, 82.44 feet
- 5. Steel Sign Post, Northeast, 3.1 feet
